Workshop Leaders Huntsville Training Associates (HTA)

William A. Henle, CHMM, has over 36 years experience teaching hazardous materials and responding to hazardous materials incidents. Recently retired from Portland Fire and Rescue, Bill was their Hazardous Materials Coordinator the last 18 years. He is a Certified Hazardous Materials Manager (CHMM), Certified Hazardous Materials Instructor, and has a B.A. degree in Education from Parsons College. He has responded to over 1,000 hazardous materials incidents, including over 300 clandestine drug labs and was responsible for all hazardous materials response operations and training for the 700 person fire department, where he was also the Team Leader for the full-time Hazmat Response Team.

He was the Chair of the State Hazmat Teams Advisory Group, and served four years as Lead Instructor in the Fire Science Technology program at Portland Community College. He has five years experience in the private environmental response field where he supervised and managed projects including emergency response to train derailments, tunnel and chemical fires, and tanker accidents. Mr. Henle has ten years previous experience at two Illinois fire departments where he taught physical science and worked as a paid on call firefighter, engineer and chief as well as teaching Fire Science part time at a local community college.

He has provided specialty training for a local Explosives Disposal Unit (EDU), FBI (Oregon) plus other law enforcement and related agencies, and been a Presenter and Lecturer at various national hazardous materials conferences across the U.S. including the International Hazmat Teams Conference, the International Fire Instructors Conference, the Certified Hazardous Materials Managers Conference, and the Continuing Challenge. He has taught NIMS for numerous civilian police and fire agencies, U.S. Air Force bases, and the U.S. Postal Service. He has four years experience as an Adjunct Instructor for the National Fire Academy.

Stephen L. Hermann CEM recently retired as the Hazardous Materials Coordinator for the Arizona Department of Public Safety, and Arizona's senior Stateon-Scene-Coordinator for hazardous materials emergency response. He has supervised over 120 serious hazardous materials highway and rail incidents over the past 35 years; has participated in raiding over 150 clan drug labs; and published over 130 articles in all of the major police, fire, and environmental magazines.

Mr. Hermann is a Senior Executive Fellow of the John F. Kennedy School of Government, Harvard University. His Bachelor of Science degree is in Explosives Technology, and he is a graduate of the U.S. Naval School Explosive Ordnance Disposal, United States Army Command and General Staff College, and the U.S. Army War College. He is a retired Army Chemical Corps Colonel in the USAR. He was awarded the Certified Emergency Manager (CEM) credential by the International Association of Emergency Managers.

He served seven years at Scottsdale Fire Department, the last 5 as Public Information Officer. He is past National Chairman of COHMED, the national organization of state and local hazardous materials enforcement officers. Steve was a script reviewer and participated in field testing for the National Fire Protection Association's videotape, "BLEVE Update"; and consultant to the Institute of Makers of Explosives for their video "Responding to Trucking Incidents Involving Commercial Explosives".

Steve has testified before subcommittees of both the U.S. House of Representatives and the United States Senate. He taught at Scottsdale Community College over 20 years, and is the author of three books dealing with hazardous materials accidents and explosives. He was Commandant of the Arizona Military Academy for the Arizona Army National Guard; formerly the State Chemical Officer, and commanded a cobra Attack Helicopter Battalion. He has guest lectured at the National Fire Academy, Arizona State University and the University of Arizona.

Course Overview

The National Incident Management System (NIMS) provides a consistent nationwide template to enable all government, private-sector, and nongovernmental organizations to work together during domestic incidents. This includes public information.

The public information systems described in NIMS are designed to effectively manage public information at an incident, regardless of the size and complexity of the situation or the number of entities involved in the response.

Note: IS-702.a is an updated version of the IS-702 course. If you have successfully completed IS-702, you may want to review the new version of the course. For credentialing purposes, the courses are equivalent.

Course Objectives:

The goal of this course is to facilitate NIMS compliance by providing you with the basic information and tools that you need to apply NIMS public information systems and protocols during incident management.

At the conclusion of this course, you should be able to:

- Define NIMS public information systems to include onsite operations, the Joint Information System (JIS), and the Joint Information Center (JIC), and how they relate to each other.
- Describe the JIS/JIC process of gathering, verifying, coordinating, and disseminating information by public information and incident management personnel.
- Identify each agency involved in given emergency situations and the role of each in the JIS to ensure appropriate situational awareness information is communicated to the public.
- Define key terms related to public information systems to include the relationship with multiagency coordination systems and the field.
- Identify typical resource requirements for public information systems.
